

Council News

GOVERNANCE AND ADMINISTRATION

Live Audio or Video Streaming of Council Meetings

COVID-19 meant Council had to move rapidly to online Ordinary Council meetings. A test of Zoom proved successful with more than 100 views of the meeting taking place. This format will be offered into the future, (in an ongoing basis).

SAROC Regional Plans

On 31 March 2020, both the Mayor and Chief Executive Officer (CEO) received a request from the South Australian Regional Organisation of Councils (SAROC) requesting feedback on their plans for the 2020/2021 financial year. A report was presented to Council and Council endorsed and requested the CEO to submit the proposed responses to SAROC including livestock considerations.

Code of Practice for Access to Council and Committee Meetings and Documents Policy

Council considered a report that proposed to alter its DCSB-G.09.02 Code of Practice for meeting procedures and access arrangements to reflect the changes noted in Attachment 1 of this report relevant to the COVID19 Pandemic and agreed that from 16 April 2020, meetings of the Council will take place by electronic means. Those unable to attend via Zoom may do so via contacting the main office to receive the telephone and meeting code number and will then be able to access via telephone only.

Informal Gatherings Policy

Council considered a report that proposed from 16 April 2020 to alter its Informal Gatherings Policy to allow informal gatherings by electronic means as per the changes recommended to the DCSB-G-9.05 Informal Gatherings Policy this policy amendment was endorsed.

Fair Treatment Policy

Council considered at the April 2020 meeting the adoption of Fair Treatment Policy, the purpose of this Policy is whereby Council commits to a culture of Fair Treatment where the rights of all are protected. These rights of protection are particularly the responsibility of those in positions of leadership within the Council organisation. This Policy was endorsed by Council at that meeting.

Boat Ramp Fees (March Meeting) Motion – Possible Rescinding

A report was presented to the April meeting of Council outlining the decision process around the March 2020 decision regarding Boat Ramp Fees. The report included an option to rescind that motion.

Council consider the option to rescind motion — Boat Ramp Fees, and decided under its role under Section 6, 7 and 8 of the Local Government Act 1999 that Council support the decision of Mayor Barber to use his casting vote in the circumstance of the decision made regarding the Boat Ramp Fees at the March 2020 Ordinary Meeting. A division was called and that division is as follows.

Sale of Land for Non Payment of Rates

A report was presented to the April 2020 ordinary meeting of Council, the purpose of this report was to present to Council the current status of the sale of properties for non-payment of rates for 3+ years as per Section 184 of the *Local Government Act, 1999*. During March 2020 staff have posted 14 Notices of Intent to Sell. Property assessments, location, land status and the amounts owing at time of notice were presented in the Council report. Council resolved at that meeting to continue to follow up some properties and other properties to go to auction.

Financial Hardship Policy (Rates and CWMS)

Council staff presented to the April 2020 ordinary meeting of Council a Financial Hardship Policy. This policy outlines the options for ratepayers seeking relief from rates due to hardship or extenuating circumstances. Council may grant relief in the form of postponement of rates (for seniors), refer the ratepayer to see an accredited financial counsellor, or negotiate a flexible debt repayment arrangement. A similar Policy was presented for CWMS fees and charges. Both Policies were endorsed by Council, with Council moving a second motion to include a public consultation campaign around the endorsement of the Policy.

Request for Lessee Rebate or Waiver

Council has received a number of requests for waiving of fees for tenancy leases/fees due to the impacts of COVID19 and these were considered in a confidential report at the April 2020 meeting.

Council News Cont'd

Request for Financial Assistance

The Streaky Bay Senior Citizens Homes Inc put forward a request for council assistance, a report was considered in confidence at the April 2020 ordinary meeting of Council and the outcome of that report remains in confidence.

Andromeda - Poochera Kaolin Mine

The Scoping Study has been updated to consider wetprocessing on site as this will deliver further significant improvement to the project economics for the Poochera project.

Baird Bay Telecommunications Tower

The lease for the Telecommunications Tower at Baird Bay has now been signed between Council and Telstra. Construction of the tower is now possible.

INFRASTRUCTURE

Bay Road Streaky Bay – Stage 2 (Anderson/Redding Intersection)

Stage two of the Bay Road Project being the Anderson Road and Redding Road Realignments. Majority of the works have been completed, now waiting on sealing contractors to complete the final section of sealing (planned to be completed in the next month). Works will then be undertaken to remediate the reserve at the intersection of Park Avenue/Redding Road and Bay Road.

Bay Road – Signage

Mayor Barber requested the installation of a Road Narrowing sign along Bay Road (just prior to the intersection with Centenary Road). The Infrastructure Manager has advised that the edge line is currently not complete and these works are expected to be completed in conjunction with the line marking of the recently sealed sections.

Reseal Program – Pygery Port Kenny Road and Witera Road

Resealing of the planned sections of the Pygery Port Kenny Road and Witera Road have been completed.

Road Construction

Works on the Kingoonya-Yantanabie Road, Haslam Highway, Dog Fence Road, Poochera Port Kenny Road and Wallala Hill Road have been completed. The construction crew are now working on Emerald Rise Road.

Roads budgeted for the 2019/2020 Financial Year are; Anderson Road, Haslam Road, Dog Fence Road, Emerald Rise Road, Poochera Port Kenny Road, Wallalla Hill Road, Kingoonya – Yantanabie Road.

Road Maintenance

Patrol grading

Staff have recently commenced patrol grading following the opening rains, graders will be working their way around the district over the coming months (moisture permitting).

Wirrulla Triangle Use

The CEO has signed the application to dedicate crown land for the purpose of having the parcel of land locally known as the "Wirrulla Triangle" dedicated to Council and required trust account to be established. We are currently awaiting confirmation of this application. Once that is received works may commence on the "Triangle".

COVID 19 UPDATE

Compliance Checks

A Local Compliance Plan has been agreed with local police and submitted to the Zone Emergency Management Committee's Area Co-ordinator as part of Council's co-ordinated Emergency Response. This provides relevant information to the Local Government Association and SAPOL alike as to how Council will assist SAPOL throughout the crisis in undertaking Compliance Checks and when those will occur. Currently Council is undertaking compliance checks each day of the week to ensure all areas are sighted and reported at least once per week. The Local Compliance Plan is updated each time directions from Federal or State Government alter the ways in which the community is able to interact.

Signing of Statutory Declarations

In response to COVID 19, the State Government has chosen to temporarily expand the categories of persons who can witness a South Australia statutory declaration and this now includes elected members and some council employees. The LGA has released guidance to assist councils and their members and employees who have not become qualified to witness South Australian statutory declarations.

As a temporary measure in response to COVID-19, the State Government has increased the categories of persons who can witness a South Australian Statutory Declaration. It has done so by virtue of the COVID-19 Emergency Response (Section 16) Regulations 2020 (Section 16 Regulations), made under section 16

of the *COVID-19 Emergency Response Act* 2020 (COVID-19 Act).

The new categories of qualified witnesses are very diverse, and include marriage celebrants, teachers, veterinary surgeons, professional engineers, and many more. For the full list, see the Section 16 Regulations <u>here</u>.

However, of specific relevance to councils are the following two categories of persons who are now qualified to witness South Australian statutory declarations by virtue of the Section 16 Regulations:

Members of a local government authority of a State or Territory (i.e. Mayors and Councillors); and

Permanent employees of a local government authority with 5 or more years of continuous service.

Public Consultation Policy Review

On 15 March 2020, the Chief Executive of the Department for Health and Wellbeing in the State of South Australia, pursuant to section 87 of the *South Australian Public Health Act 2011*, declared that an emergency which threatens to cause the death of, or injury or other damage to the health of any person is occurring or about to occur in relation to the transmission of COVID-19, and declared the emergency to be a public health emergency.

On 22 March 2020, the State Co-ordinator for the State of South Australia declared, pursuant to section 23 of the *Emergency Management Act 2004*, that a Major Emergency is occurring in respect of the outbreak of the Human Disease named COVID-19 within South Australia.

On 8 April 2020 the Minister for Transport, Infrastructure and Local Government issued a notice pursuant to section 302B of the Local Government Act 1999, the Public Access and Public Consultation Notice (No 2) 2020 (Notice No 2) varying or suspending the operation of the specified provisions of the Local Government Act 1999 as set out in Schedule 1 to Notice No 2. Notice No 2 commenced operation on 8 April 2020.

These provisions included requirements to hold Public Meetings.

Annual Business Plan Adoption

Direction No4 from the Minister has allowed an extension for all Councils until 30 November 2020 to have their Annual Business Plans Adopted. Council however, do not feel this will be necessary and believe we will have ours ready for adoption on schedule.

Strategic Plan Review

Although Councils have been provided an extension until February 2021 to complete their reviews of their strategic plan (as per the Minister's Direction No4), Council believes our plan will be ready for adoption by November 2020 as per normal practice. The plan is currently with Senior Staff for development and drafting and will be taken to the May Leadership Team meeting for discussion. The plan may need further input at that time as it is a considerably different document to our current Strategic Plan and includes the development of a Corporate Plan to underpin how Council will achieve the Strategic Plan and provide measurement tools for reporting annually. During June/July it is expected a workshop will be held with Elected Members to refine the document presented by Senior Staff. The Strategic and Corporate Plans will then be sent to the Community for Public Consultation and Feedback.

Campground Closures

Speeds Point Campground remains closed under the state government direction and gazettal of no camping permitted on Crown Land.

With the easing of restrictions the opening on campgrounds will be reviewed, and opening expected to occur this week.

Playground Opening

The State Government and SA Health have recommended that Council's reopen Playgrounds and Skate Parks this week.

Council's Infrastructure team were successful in opening all our playgrounds by the end of last week.

Staff will be undertaking any required maintenance and cleaning prior to the reopening.

Library

The Library will remain closed while appropriate measures are put in place regarding new eased restrictions.

COVID19 District Council of Streaky Bay NON-ESSENTIAL TRAVEL IN AND OUT OF THE DISTRICT

The Prime Minister and the South Australian Premier, as well as the relevant government health representatives have today announced the release of a 3 stage process for the lifting of restrictions relating to COVID19 through to July 2020.

Phase 1 is cautious and gentle, increasing numbers of people at funerals (weddings remain the same), Council has already opened its playgrounds, and the majority of our students have returned to school. Golfers have continued on our Golf Courses, our budding fitness industry can return to outdoor boot camps, and by summer our pool will reopen, stage 2 will include our organised community sport.

The reopening of outdoor dining at our local café's and restaurants enabling a reboot of our wonderful local café's, stage 2 beauty parlours and massage and later in Stage 3 our hotels.

Our Community has seen the suffering in much of our local economy, particularly some retail sectors, café's, hotels, accommodation and our tourism operators have incurred due to the required COVID19 restrictions implemented, including the advice on non-essential travel. Our region incurred an essential cessation of our visitor economy, particularly around the Easter period, and this in addition to COVID19, had a significant impact on many of our businesses.

We acknowledge the restrictions were implemented for the safety of all of our community, and the community has seen some wonderful and entrepreneurial adaptations and changes in service delivery by our businesses. The community has got behind those businesses where they can, to support them in the current environment, and our community will continue this local support.

The advice today included a recommendation that local and intrastate travel can now occur and our state premier encourages it, particularly caravanning and camping. Council acknowledges that there has been and may still be some insecurities in the community regarding visitation to the region. Council however would like to reiterate that this advice has been in accordance with federal health authorities, and a slow and gradual reintroduction of visitation and visitor spend to our region is critical for the recovery of many of our businesses and we ask the community to show empathy and welcome this gradual return of visitation for the benefit of this sector in our economy. Council endorses the sentiments of Prime Minister Scott Morrison "every person, every job, every future matters" and we welcome the proposed staged lifting of restrictions.

Councils asks our communities and our visitors to continue their personal responsibilities in retaining the social distancing, personal hygiene and other restrictions. Every one of us must continue to play our part to keep our community safe. If we can do the right thing together, we can get through the next few months and gradually return to a Covid safe life.

Frequently Asked Questions

Step 1: From 11 May Public and Outdoor Activities

South Australia assesses the current situation based on the Prime Minister and the National Cabinet's positions, and advice from SA Health on the specific circumstances in our state.

On 8 May 2020, National Cabinet agreed to a first phase of easing certain COVID-19 restrictions. Based on expert advice by the Australian Health Protection Principal Committee, National Cabinet decided that states and territories should determine how to implement this in response to their unique circumstances and success to date in flattening the curve.

A <u>South Australian roadmap</u> has been developed to detail the stage of easing of restrictions and will start from 11 May. This is subject to public health performance and the State Coordinator's assessment of the situation at that time.

Remember:

- · Gatherings should be 10 or less people at any time
- Keep 1.5 metres distance from others
- 1 person per 4 square metres (density requirement)
- If you have a cold or flu symptoms, seek testing and stay home until you are well.
- Wash your hands often, wipe frequently touched surfaces, and cover coughs and sneezes.
- Vulnerable people like the elderly and people with chronic health conditions should talk to their doctor about what is appropriate for them.

Regional Travel

Can I go to my holiday home in a regional area?

Yes. Previous advice was to re-consider your need to travel to regional areas because we were trying to slow the spread of COVID-19 particularly in our regional areas within South Australia. This advice has now been relaxed.

Universities, TAFE or other VET institutions

Can I go to university, TAFE SA or another VET institution?

Yes, you can. These institutions were never directed to close, but moved to remote learning models as an extra precaution to protect their staff and students.

However, SA Health has recently advised that it is safe for students and staff to attend university, TAFE and other VET institutions, and encouraged them to feel comfortable returning to attend in-person when possible.

However, if you have a chronic medical condition or a compromised immune system, you should consult your GP in first instance. If you are feeling unwell, you should stay home.



STEP 1 - FROM 11 MAY

Outdoor dining for restaurants and cafes

Can I open my restaurant or cafe if I have outdoor seating?

Yes, from 11 May outdoor dining of up to 10 patrons is permitted for restaurants and cafes. Patrons must be seated at tables. Alcohol is not permitted to be served or consumed on the premises. There will be a limit to the number of people on site to 1 person per 4 square metres (density requirement), and practice good hygiene.

Community, youth and RSL halls

Can I go to a recreation centre (community centre/hall, club, , RSL club)?

From 11 May 2020, recreation centres are allowed to operate for public gatherings of a maximum of up to 10 people. This number excludes any staff necessary to facilitate the gathering. Density requirements and social distancing principles continue to apply. No sporting activities or training may be conducted inside the facility.

As was already the case prior to 11 May, some facilities are also open for the purpose of hosting essential voluntary or public services, such as food banks or homeless services.

They will also still be allowed to provide goods, food and beverages to take away.

Auctions and inspections

Can house sales be conducted via auction and are open inspections allowed?

From 11 May 2020, in-person open house inspections and real estate auctions are allowed, Auction houses are also allowed to open for both inspections and auctions. but the number of attendees in all cases must be restricted to a maximum of 10 participants at any time

This number excludes the auctioneer, real estate agent or host, as well as any staff necessary to facilitate the activity. People are encouraged to minimise the number of people present at all times.

People who organise or host auctions or open house inspections must keep records of each attendee to each separate auction or open inspection, including the contact details of each attendee, to assist with contact tracing if required. These may be requested by an Authorised Officer. The form will be available for download at www.sa.gov.au.

Social distancing principles and the density requirement continue to apply.

Participants are encouraged to adopt good hand hygiene practices and the organiser(s) or host(s) should arrange appropriate and frequent environmental cleaning and disinfection.

Local government libraries

Can I go to the library? Can I open our library?

Local government libraries will be able to re-open with limitations including a limit of 10 patrons present at any time (excluding library staff), limit the number of people on site to 1 person per 4 square metres (density requirement), practice good hygiene and provided attendee records are kept.



STEP 1 - FROM 11 MAY

People will have to observe, and encourage attendees to adhere to, social distancing principles, requiring everyone to try to maintain at least 1.5 metres physical distance between one another at all times.

Note: Depending on the size of the library, a lower maximum limit may apply, as libraries also need to comply with the density requirement as outlined above.

Sports Training (outdoor only)

Can I train with my team outdoors?

Yes, outdoor team training is allowed, as long as you follow the density requirement, the 1.5 metre social distance rule, and you have no more than 10 people participating in a group. This number excludes any staff necessary to facilitate the training

Indoor sports and sports competitions will remain prohibited for now.

People are encouraged to limit the number of people in any location as much as possible (for example: no more than 1 parent per child), to get changed and shower at home, and practice good hand hygiene.

Sports clubs and organisations are encouraged to increase the frequency of environmental and disinfection cleaning.

Funerals

Can I organise or attend a funeral?

Funerals can still occur in South Australia.

From 11 May, the maximum number of mourners that is allowed to attend is <u>20 if the funeral is held indoors</u>, and <u>30 if it is held outdoors</u>. This excludes those officiating the funeral, and other staff necessary to facilitate the funeral.

This is an increase on the maximum numbers that applied prior to 11 May (previously the numbers were 10 indoors and 15 people outdoors). While more people will be allowed to attend funerals, the density requirement and social distancing principles continue to apply.

No food or beverages are to be provided for consumption.

Attendee records must be kept, including each attendee's contact details, to assist with contact tracing if required. These may be requested by an Authorised Officer. The form will be available for download at www.sa.gov.au.

Worship, weddings and ceremonies

Can I get married?

Weddings can still be conducted in South Australia. Commencing from 11 May 2020, up to 10 guests can attend. This is excluding the celebrant and any staff necessary to facilitate the event.

This is an increase on the previous maximum number of people (which was 5 in total).

No food or beverages are to be provided for consumption.

Attendee records must be kept, including each attendee's contact details, to assist with contact tracing if required. These may be requested by an Authorised Officer. The form will be available for download at www.sa.gov.au.

Can I visit a church, mosque or other place of worship?

From 11 May 2020, places of worship are allowed to be open, as long as no more than 10 people attend at any one time.

Religious gatherings, private worship or small religious ceremonies of up to 10 people will now be allowed. Social distancing principles and density requirements continue to apply.

Places of worship or organisers of religious gatherings are strongly advised to keep records of each attendee to each ceremony, service or gathering, including the contact details of each attendee, to assist with contact tracing if required.

Larger services continue to be prohibited.

Prior to 11 May, all places of worship were closed to the public, although the recording or streaming of services was allowed with only essential participants and social distancing requirements observed. Recording or live streaming scenario remains an option under the latest Direction.

Pools

Can I go to the public swimming pool?

From 11 May restrictions on public swimming pools will be eased, with lap swimming and recreational swimming allowed, as long as the following requirements are complied with:

- there is a maximum of 10 swimmers in each separate pool at any time
- no spectators are permitted, except for up to one parent/carer per swimmer if necessary
- there is a maximum of one person per lane for lap swimming.
- change and shower facilities are not permitted to be used (but toilet facilities may be made available).

As was already the case prior to 11 May, supervised hydrotherapy, registered swimming club training and elite athlete (including divers) can all still continue, provided that the total number of people does not exceed 10 and the density requirement is complied with.

Campgrounds and caravan parks

Can I go camping at national parks and reserves?

Yes, South Australia is re-opening camp sites at national parks and reserves. However, gatherings should be 10 or less people at any time, and you still should practice social distancing of 1.5 metres and good hygiene practices.

"Badges and Buttons were sold for Army Nurses and War Nurses, and tins of jam, lever top tins (treacle tins) and books etc. for R.A.N Friendly Union and R.N."

Marine Safety Notice—Streaky Bay, Sceale Bay, Baird Bay & Haslam

Locally available 24/7 Adelaide Monitored VHF Marine Emergency Radio Service is on Ch 16 and on supplementary CH 67, via equipment on Government Radio Network towers at Elliston and Streaky Bay's Gibson Peninsula and is well receivable within Streaky Bay. However in some areas both inside and outside of some of the other bays, that signal can be marginal due to terrain shadowing.

Daylight Hours Local VHF Marine Radio Services: The call signs are VMR Baird Bay, VMR Haslam and SES Streaky Bay these are manned by SES members. Call sign VMR Streaky Bay is a non SES operation from Killas Service Station, Wells Street -manned during business

Local Services Provided:

Locally operated stations primarily monitor for general calls and the hours are usually 8.00am to 5.30pm varying to 8.30pm. Some stations can provide you with a signal check, but they do not normally offer a regular voyage booking/tracking service unless that is agreed by prior arrangement. They also can be used for emergency calls and will monitor emergency calls.

Local Streaky Bay UHF CB Repeater is CH7 and can often be used for all types of emergencies during long term blackouts to Streaky Bay area mobile phone services. Radius is approx 35kms from Streaky Bay
