Council News

GOVERNANCE AND ADMINISTRATION

Annual Business Plan and Budget

The Annual Business Plan Budget has been adopted a copy of that document is available by visiting www.streakybay.sa.gov.au

Disability Access and Inclusion Plan

Council is required under the relevant legislation to develop and implement a Disability Access and Inclusion Plan. This plan was endorsed for Public Consultation by Council and is currently out to Public Consultation.

Local Government Reform Bill 2020

The State Government has put forward a Bill with a number of proposed amendments in regards to a Local Government Reform. Council members attended a workshop on the proposed amendments prior to receiving a report with recommended submission suggestions. The full report is available in the July 2020 ordinary Council Agenda.

BUSINESS AND ADMINISTRATION SERVICES

Sale of Land for Non Payment of Rates

During 2019/2020, staff have been progressing sale of properties for non-payment of rates. As Council has not previously undertaken debt management in relation to rates, staff have been mindful of giving the ratepayer some time and ability to pay.

Staff will try to contact those ratepayers that haven't entered into any direct debit arrangements, to progress further payments, prior to the August Council Meeting, where a final report will be provided to finalise properties that are to be sold.

Blancheport Rise Vacant Land – Lease

The Manager, Business and Administration provided a further report to Council at the July 2020 meeting as Council were considering selling or leasing the land, the following information was provided in that report:

- Costs to subdivide the land to enable the Blancheport Land Reserves could be subdivided from the rural land.
- Costs to fence the land for it to be suitable for grazing
- Costs to fence the rubble pit (that has no further benefit to Council), as the rubble supply has been exhausted, rather than remediation of the pit.
- Possible futures uses of the land.

Council resolved to retain the land and seek registrations of interest for leasing of the land. Discussions to occur with any prospective lessees in relation to fencing of the land being incorporated as part of the lease.

Sceale Bay Road Land (potential landfill site) / Vacant Council Owned Land

The Manager, Business and Administration, provided a report to the July Council Meeting, advising Council that prior to undertaking a farming/grazing lease for this property, an application for clearance, would need to be undertaken, in accordance with the following requirements relating to regulation 11(26) Native Vegetation Regulations. Council has decided to defer any action relating to this property until Asset Management discussions occur.

Discovery Parks Deed of Renewal

Discovery Parks have undertaken their right to renew their Management Contract for the Foreshore Tourist Park, for a further 3 years. Council agreed for the Deeds of Renewal be signed under seal by the CEO and the Mayor. It should be noted that there are no changes to the lease.

INFRASTRUCTURE

Foreshore Tourist Park Development

A full survey of the Caravan Park has been completed including new and existing infrastructure. These new survey plans will be used for the future redevelopment of the Caravan Park. Renewal/upgrade of amenities has been bought forward as a priority.

Wirrulla Sporting Club Irrigation Project (Drought Communities Fund)

Works have been completed.

Project planned for October 2020

Wells Street – School Zone Precinct

MICW has met with the School Governing Council and the Road Safety Committee. Discussions are continuing and we hope to reach a DPTI acceptable outcome shortly. Once decided, a report will be presented to Council for approval.

Speed Hump Requests

A request has been sent to DPTI for approval for the installation of a speed hump in Sceale Bay.

Road Construction

The construction team are currently working on Benbarber Road from the bitumen to Tyinga Road.

Roads budgeted for the 2020/2021 Financial Year are; Anderson Road, Haslam Road, Dog Fence Road, Emerald Rise Road, Poochera Port Kenny Road, Wallalla Hill Road, Kingoonya-Yantanabie Road.

Road Maintenance

Graders will be working their way around the district (moisture permitting). During this patrol grading season (commencing in April) staff have patrol graded approximately 685 kilometers.

Jetty Platform Upgrade and Future

Council received a report to the May ordinary meeting of Council outlining proposed upgrade information and short term closure of the Jetty Platform located in Streaky Bay. That report also included options for Council to consider pursuing ownership of the facility. Council resolved at the meeting lay the report on the table until further asset costing considerations are available, those considerations have yet to be reported back to Council.

Council in addition to this spoke to the Premier in regards to Council taking on the repairs. The Premiers Office has since advised that DPTI are currently undertaking planning and intend to undertake remedial works as soon as practicable following the completion of the plans.

Dentist Roof Replacement

The current dentist building (Council owned) is required to have the roof replaced. Council authorised relevant staff to seek two quotes and provide funding for the replacement, with the required funds to be allocated during budget review 1.

Tree Maintenance

A question in Business arising from the May Ordinary meeting of Council Minutes was raised by Cr Trezona regarding the trees in Streaky Bay. The MICW advised that Councils existing budget had already been expended on removal of trees and other maintenance. Staff are investigating alternative removal methods. There are concerns around the probability of a fungus affecting trees and the trialling of heavy lopping to encourage regrowth (full response available in June meeting Agenda).

Review CDL Operating

New Opening hours decided, to bring in line with Transfer Station and increase Safety of Workers. New hours began on the 2 June 2020. New hours will be reviewed over the coming weeks, once backlog begins to reduce due to the CDL being close for a period of time due to COVID-19. Operational costs to be considered in "whole of Waste & Recycling review".

Blue Lid Bin Collection Service

Council has endorsed a Report recommending that the program be continued by Council at reviewed pricing structures. Notification to users to be conducted shortly. Consultation with "High Use" Customers underway in an attempt to reduce any potential impacts from pricing review. Administration being processed currently.

Philip Street – Stormwater Management

MICW and Thirsty Construction encountered a hurdle with SAPN associated with a solitary stobie pole. Excavation cannot be carried out within 3 metres of the pole. MICW and Thirsty Constructions are developing an alternative solution.

Gibson Peninsula Stormwater Remediation

Further discussions by the MICW with D & J Williams have resulted in a re-think of the Stormwater Management at the corner of Back Beach Rd and Cape Bauer Road. MICW to hold discussions with Landscapes SA (NRM) to ensure successful outcome.

PLANNING AND DEVELOPMENT

Progress of Transition to the PDI Act

As of 31 July 2020, all development applications received by Phase 2 Councils will be subject to the new Act.

Council News Cont'd

Development Act Delegations – Planning Consultant

Whilst the shared service agreement is being finalised the appointed Regional Assessment Manager is unable to assist Council. In the interim Council has engaged a consultant planner to undertake the required duties, as Council currently does not have appropriately qualified staff to undertake those duties in house.

In addition to this Council received a report to the July meeting to prepare Council for the implementation of the *Planning, Development and Infrastructure Act 2016* (PDI Act). The report provided further information that to allow Council to continue to operate regarding its obligations under the PDI Act new Delegation Schedules will need to be approved by Council. These delegations were approved at that meeting.

Strategic Planning and Development Policy – Section 41 Committee

A report was presented to Council outlining the potential for the implementation of this committee under the relevant Act. The Council endorsed at the meeting that the required Terms of Reference and objectives of this Committee be included in the existing Community and Economic Development Committee and the two Committee's be combined. A Draft amended Terms of Reference was presented to the existing committee with a view to being endorsed by Council at the August ordinary meeting.

Finlayson Road Intersection with Highway (both ends)

A deed has been provided by the solicitors and that deed was endorsed for the signing under Council's common seal at the July ordinary meeting of Council.

Tyringa Road Realignment/Land Swap

The land swap and realignment have been gazetted as part of the public consultation process. No objections, nor requests for easement were received. The surveyor will now complete the final survey and complete the process to conclude the road opening and closing process.

Andromeda Mine Site – Unmade Road Reserve

Council considered a report at the July 2020 meeting to issue a Section 222 permit to Andromeda metals for the purposes of utilising an unmade road within the proposed mining site. This Permit was authorised. Further to this Council agreed to undertake a survey and commence discussions with adjoining land owners to close the existing road reserve and open a new road reserve in the preferred road location.

Moore's Boat Ramp By-Law

To ensure the structural integrity of the new boat ramp for the long term, Council will implement By Law No 4 provisions to restrict the use of the ramp and pontoons to only the launch and retrieval of vessels. The mooring of vessels to the boat ramp will be strictly prohibited and become an offence subject to expiation. Council received a report to the July ordinary meeting outlining signage wording requirements for the site and this will be implemented as soon as practicable.

COMMUNITY & ECONOMIC DEVELOPMENT

Shovel Ready Projects

Council received a report from the MCED regarding Council's need to prepare shovel ready projects as a means to being in the running for future competitive grant funding. Current competitive grant rounds require applicants to have detailed costings, drawings, and development approval and applicant commitments prior to submission.

Infrastructure SA – 20 Year Infrastructure Strategy

MCED submitted a report to Council outlining the key elements of this strategy relevant to the Eyre Peninsula and the District Council of Streaky Bay. See July 2020 Agenda for a copy of the full report.

Proposed SA Waste Strategy – Feedback Submission

MCED submitted a report to Council outlining the proposed strategy and some suggestions for feedback to be considered by Council. The submission is due on August 14, staff have asked that all feedback be provided by August 10 to enable submission collation and submission.

Streaky Bay Youth Precinct

A report was presented to Council providing details of a concept plan for the development of the Skate Park and funding application that was initially submitted and was unsuccessful. The CED team has commenced extensive consultation on the plan with a variety of stakeholders and a second stage meeting with the proposed consultant has been arranged for late August/early September.

The project funding is yet to be committed by Council and we encourage you to forward your support for this project to davisjessica@streakybay.sa.gov.au.

ArtsUp have submitted a funding application for the design, construction and implementation of appropriate featured art sculptures for this project.

Council News Cont'd

Streaky Bay Area School Pool

Draft three (3) year lease agreement has been received, required funding has been allocated within the Draft Budget and the agreement will be presented at the August 2020 meeting of Council.

Streaky School Community Library

Streaky Bay Area School submitted an application for consideration in the Draft Budget to continue the funding of 1 day per week additional staffing. Council did not feel that they could continue that funding in the current climate and the funding has not been included in the Budget.

Eyre Peninsula Regional Website

The new EP website has now gone live. This website provides a direct feed in from Australian Tourism Data Warehouse. Visitor Centre staff will be trained and authorised to provide updates to our regions information.

Streaky Bay Visitor Guides

The marketing campaign of the A5 Visitors Guide will commence in August and if there is sufficient support from our members and local businesses the guide will be printed and be cost neutral to SBT&B. Should this exercise not be cost neutral SBT&B will reprint the existing A4 guides for the approaching summer season.

South Aussie with Cusi – Filming

Filming was a success. First episode of SATC's funded program aired on Sunday 26, featuring Murphy's Haystacks, EP Cruises, Smoky Bay Premium Oysters and Fowlers Bay, this was a great episode. The Streaky Bay episode airs August 23.

Tractor Beach Campground Development

Native Vegetation Application has been approved, awaiting confirmation from Native Vegetation Council (July 4) that fees will be waived. Environmental Management Plan draft has now been completed and sent to Coastal Protection Board for approval. Council have endorsed staff to proceed with Care and Control of the portion of the site that is Crown Land and Development approval is now being sought.

Andromeda –Poochera Kaolin Mine

Results of the Pre-Feasibility Study (PFS) were released during the quarter which reinforced the potential for the Poochera Halloysite-Kaolin Project to be a long-term supplier of high-quality halloysite-kaolin product able to meet a growing global demand from ceramic industry manufacturers.

The PFS is based on an expanded Life of Mine (LOM) of 26 years and inclusion of onsite wet-processing, thereby delivering further significant improvement to the Project economics. Key metrics for the PFS are:

- Pre-tax NPV_{8%} of A\$736M (after-tax NPV_{8%} of A\$511M);
- Pre-tax IRR of 175% (after-tax IRR of 135%);
- Project cashflow of A\$1.97B pre-tax and A\$1.39B after-tax;
- All In Sustaining Cost (AISC) of A\$354/tonne of refined premium halloysite kaolin product with an anticipated selling price of A\$700/tonne;
- Pre-production capital estimated at A\$13M with a maximum cash requirement of A\$28M prior to initial revenues being received;
- Payback period of 15 months from commencement of mining;
- On-site wet-processing plant fully funded by revenues received from DSO production, constructed in the Year 2 of operations at a cost of A\$56M.

Maiden Carey's Well Ore Reserve of 12.5Mt bright white kaolinized granite classified as Probable Reserves comprising 15% halloysite and 78% kaolinite in the minus 45 micron fraction determined.

Drilling confirms bright white kaolin over a 2 km strike between two highgrade halloysite zones at Condoorie with final assays awaited.

Project to be renamed Great White Kaolin Project from 1 August 2020.

REGULATING

Dogs On Leash Signage

As per the Animal Management Plan, the General Inspector and works staff have undertaken the installation of Dogs on Leash signs at Scales Bay, Back Beach, Haslam, Perlubie, Surfers Beach, Hallys Beach, Yanerbie.

Burning within townships

Council has been receiving enquiries in relation to burning unauthorised large piles of vegetation, which is against current legislation, within townships.

Animal Registrations

The notices for Animal Registrations have been sent out by the Dog and Cat Management Board, to date 40% of renewals have been completed. Further reminder notices, will be sent out by the Dog and Cat Management Board by email to the owners, in the first week in August. Owners have until 31 August to complete their animal registrations.

Council News Cont'd

An automatic late fee will be charged on the 1 September for any unpaid registrations.

Illegal camping/homelessness

Consultation with other agencies is being undertaken to find options in relation to emergency housing locally within Streaky Bay, when the need arises.

Customer Services Officer

Council's Customer Service Officer, Chelsea Matthews has tendered her resignation, with her last day being the 7 August. Chelsea has been successful in obtaining a job with a small law firm, EMA Legal, as a Customer Service Officer, and she will commence her role on the 10 August.

The Manager, Business Administration Services, personally wishes Chelsea all the best for her future ventures, and hope that she is able to utilise some of the aspects that she has learnt by being with the District Council of Streaky Bay, and she will be certainly missed.

Council is seeking expression of interest (EOI) from persons interested in leasing Lot 1004, Hd Ripon, which is approximately 53 ha of land located behind Blancheport, west of the township of Streaky Bay.

The EOI is open to all persons, community groups, and businesses.

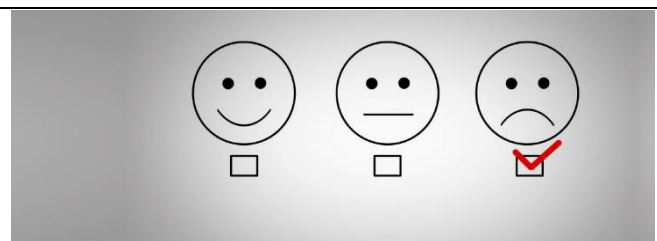

PUBLIC ACTIVITIES UPDATE

The Emergency Management (Public Activities No 5) (COVID 19) Direction 2020 has been revoked and replaced by the Emergency Management (Public Activities No 6) (COVID 19) Direction 2020. This new direction comes into effect as of 0001 Wednesday 5 August 2020.

Changes of note to defined public activities include a new maximum capacity requirement and updates to the consumption of food and beverages at defined public activities.

Maximum Capacity Requirement Update

- A gathering of more than 10 people at a residential premise is now a prohibited gathering.
- A person must not allow, organise or attend a prohibited gathering at a residential address.

Changes to Food & Beverage Consumption

- Alcoholic Beverages may be consumed by spectators at sporting events if the spectator remains seated.
- Food and beverages (including alcohol) must be consumed by patrons while seated at tables that are physically separate from any bar or where orders are taken
- Food and beverages at recreational facility (eg mini golf, pool, hall, tenpin bowling, high ropes course etc) must be consumed at an area separate from a bar/where orders are taken and within the group that are attending the facility.

****Note-** the information above highlights the changes made and does not reflect all requirements under the Public Activity No 6 Direction. the public are encouraged to see the full direction for further information.

SA BORDER RESTRICTIONS

Victoria

From 12:01 am, Wednesday 29 July

- South Australians will no longer be able to return to SA from Victoria
- To be considered for cross border community travel, you must reside within 40 km of the border (previously 50 km)
- Victorian residents, other than Essential Travellers, are not permitted to travel to South Australia.
- Checkpoints or road blocks will be set up at all border crossings between South Australia and Victoria.

All other states

Travellers from NT, QLD, TAS and WA are able to enter South Australia directly without restriction.

Travellers from ACT and NSW, other than essential travellers, will be required to:

- self-quarantine for 14 days after entering SA
- submit for COVID-19 testing on:
 - the first day of entry to SA (the day of arrival)
 - the twelfth day of arrival.

EVENTS AND DEFINED PUBLIC ACTIVITIES

Business / Events

All businesses must follow density requirements and physical distancing principles.

The current Direction outlines a number of *Defined public activities*.

EVENTS AND DEFINED PUBLIC ACTIVITIES Cont...

All businesses that conduct a Defined public activity must have a COVID-Safe Plan.

Some Defined public activities require a business to complete contact tracing records. You can find a list of the defined public activities here:

Defined public activities

A defined public activity means:

- onsite purchase and consumption of food or beverages (whether occurring in an indoor or outdoor area)
- sport (including sports training), fitness or recreation activities
- indoor public meetings
- ceremonies
- provision of personal care services
- provision of public entertainment
- provision of recreational transport
- the operation of a nightclub
- the operation of relevant licensed premises
- the operation of a casino or gaming area
- auctions and inspections of premises for the purpose of sale or rental of any property
- driver instruction.

Maximum occupancy requirements for Defined public activities

The density requirement of 1 person per 2 square metres applies for Defined public activities. The maximum number of attendees at a place of business will be determined by its size. These requirements apply only to patrons, not staff.

What businesses need to create a COVID Management Plan?

A COVID Management Plan is required in respect of each of the following:

- if more than 1 000 persons are reasonably expected to be present at or participating in the activity;
- the onsite purchase and consumption of food or beverages at a place where the total number of persons present at the place for the purpose of the purchase and consumption of food or beverages is reasonably expected to exceed 1 000 people;
- the operation of a nightclub;
- the operation of relevant licensed premises

Contact tracing

Some businesses are required to make and retain records of patrons attending public activities. This must include the name of each patron in attendance, as well as their phone number or email address, along with the time and date of their attendance.

Contact tracing records must be presented at the request of an authorised officer. These records must only be used in the event that tracing of contacts needs to occur. For example, the records can't be used for marketing or similar purposes.

New restrictions in SA

FROM 5 AUGUST



Gatherings at residential premises
Maximum 10 people

Grants are available for a broad range of grassroots, community-led initiatives that directly and clearly benefit local communities. Applications are accepted on an ongoing basis and assessed quarterly. Three tiers of grants are available:

- Up to \$20,000 – projects to be finalised within 18 months of approval;
- Up to \$60,000 – projects to be finalised within 18 months of approval;
- Up to \$150,000 – applications for this tier are by Expression of Interest, and multi-year projects (up to three years) are welcomed. Applicants must speak with the TTTT team to discuss their project before applying.

RESPECT OTHER SKATERS

- Sharing and being mindful of other people. Watch out for the little tackers – they idolise the older skater and scooter kids and strive to learn more so please watch out for them
- Don't cut in front of everybody else.
- Just wait your turn and make sure no one else is going in that general area so you can avoid hurting yourself and others.

BE AWARE OF YOUR SURROUNDINGS

The skatepark is a fast moving environment. You have skateboards, bikes, scooters and everything else you can think of moving around and flying about. Always look around you before you do your line. The last thing you want is to crash into someone and hurt yourself or others. So always look around and make sure the coast is clear.

DON'T REST YOUR BOARD ON THE COPING IF YOU'RE NOT DROPPING IN

While this may not seem like a bad thing, you run the risk of the board dropping into the bowl while someone else is doing their line, or they may be going where you are. For a safe distance, stand a few feet back and go when the coast is clear.

WHEN IN DOUBT, COMMUNICATE

Communication is key at a skatepark. Not sure if someone's going down an obstacle? Ask them.. Everyone at the skatepark is there to have fun, so the nicer you ask them, they'll be more than willing to do it.

DON'T BE MEAN OR RUDE TO THE KIDS

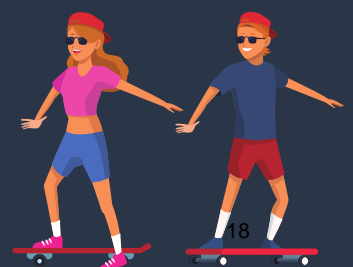
This really should go without saying, but if you see someone who's younger and learning, try to help them out.

4. At approximately halfway through the program, you and your counsellor review the treatment plan, to highlight and celebrate your achievements, set new goals for the remaining sessions, and/or adjust goals based on what positive changes have been made.
5. Planning the end of the counselling sessions is based around achievement of your treatment goals.

THE LWB APPROACH

We see people as individuals who have unique needs and tailor our services to meet their needs by adopting a client centred approach.

We adopt a harm-minimisation framework in the Alcohol and Other Drug programs, supporting our clients to identify and achieve their identified treatment goals.

Our goal is to help each person see their personal strengths and use these to achieve long lasting changes in their lives.

Our services are designed and delivered in ways that are inclusive, appropriate and respectful to all people.

DRUG AND ALCOHOL COUNSELLING SERVICE

- Counselling is voluntary.
- Services are available to all people from the age of 12 years.
- Each person is eligible for up to 14-sessions per counselling episode.
- Counselling sessions are held at our local offices and will operate within normal business hours – telephone and online support sessions will be available where significant barriers to accessing office based appointments exist.
- Services intervene at the earliest possible point of crisis to minimise ongoing dependency on services.
- LWB collaborates with other agencies, ensuring a comprehensive and holistic approach in meeting the client's needs; safety and recognising/addressing the needs of client's children where applicable.
- Where there is a wait list we will work with the individual to remain connected and engaged.
- Group sessions utilise SMART Recovery Methodology providing relapse prevention strategies through education and group activities.

Life Without Barriers' (LWB) Drug and Alcohol Counselling Service provides one-on-one individualised counselling and group sessions to people with identifiable alcohol and/or other drugs dependency and/or concerned parents or significant others.

Individuals accessing the service can either refer themselves; get referred by their GP, Health Services, Mental Health Services, Police, Alcohol & Drug Information Service (ADIS), Disability Service and other Community Organisations.

LWB offers the Drug and Alcohol Counselling services in targeted country and metropolitan regions of South Australia and also connect clients in this program to other agencies and organisations that can provide further assistance.

JETTY POOL UPDATE

The Streaky Bay Jetty Pool Committee Inc, formed in 2011, still meets regularly to work through processes to maintain and make improvements to Streaky Bay's favourite asset, the Jetty Pool.

The Committee is working with the District Council of Streaky Bay and Department of Transport and Infrastructure to progress the pool platform project, which has been in the works for a couple of years. The Committee feels good progress is being made and hope to have construction underway in time for Summer. Allocation of Drought Relief Funding through the District Council of Streaky Bay is very appreciated and will be put to good use.

The jetty plaques fundraiser is still an active project. However, the supplier's circumstances have meant no new orders have been able to be placed. A Streaky Bay business is currently investigating local manufacture of the plaques, which will be an excellent outcome. This fundraiser will be promoted again when supply details are finalised.

Reusable calico shopping bags with the Jetty Pool logo are available for purchase from Bay Funktion, Streaky Surf and Elliott's Bakery. At \$5, they are a practical alternative to gift wrapping, while contributing to fundraising for the maintenance and improvements to the Jetty Pool.

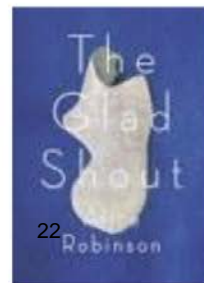
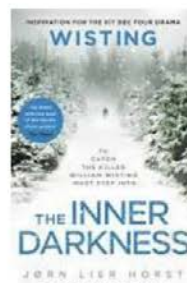
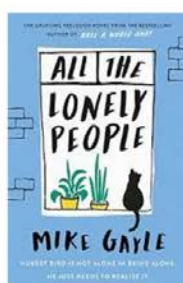
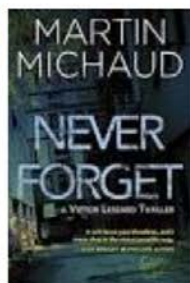
READ WITH FRIENDS IN A BOOK CLUB
