Council News

GOVERNANCE AND ADMINISTRATION

Representation Review Options

Public Consultation regarding the first draft of the Representation Review has finalised with six responses being received. An Options Paper was presented to Council at the January meeting where Council resolved to essentially remain with Mayor, Wards, and number of elected members as status quo. A second report will be sent out for 3 further weeks of Public Consultation as required by the Act.

Development Application Amendment Fees

Council considered a report to reduce the fees associated with development application amendments. It was identified that previously there was no charge, and the existing fee set was quite high given the time taken to address amendments. Council resolved to reduce this fee to \$30.

Eyre Peninsula Local Government Assoc. Regional Capacity Building Projects

The EPLGA has identified several projects to fund that will aim to build the capacity, skills, and knowledge of participating staff. These projects included;

- Regional Building, Fire and Safety Group
- Shared Services delivery modelling (between organisations)
- Regional Safety Focus Group
- Streamlining Administrative Services
- Regional Works Managers Group Support
- Regional Roadside Vegetation Legislation – Gap Analysis and options report
- EPLGA Conference
- Regional Tourism Advisory Committee – Seed Funding

Coast Protection Board Inquiry

The Environment Resources and Development Committee is now receiving submissions in relation to the status and potential for reform to the Coast Protection Act 1972 and its associated regulations.

South Australian Coastal Council's Alliance

Council resolved to vote in favour of joining the alliance and the proposed subscription model.

BUSINESS AND ADMINISTRATION SERVICES

Blancheport Land Lease Agreement

Council received a report regarding the outcomes of the Expression of Interest process in leasing land behind the Blancheport subdivision.

The Streaky Bay Golf Club was successful in their application and Council resolved at the February 2021 meeting the conditions of that lease. (Full report available within the Agenda).

ECONOMIC DEVELOPMENT

Bendigo Bank – Streaky Bay

Council received a report to the March meeting outlining Bendigo Community Bank's interest in opening a branch within Streaky Bay. The report nominated several options that could potentially be available. Council resolved to enable staff to continue investigations for an appropriate location.

Andromeda Metals

The Andromeda Metals Great White Kaolin project site at Poochera is progressing through the various approval stages. Council endorsed at the February 2021 ordinary meeting of Council to endorse the applications for a Mining Lease and Miscellaneous Purposes Licence for the site.

Council received a request to provide sponsorship of \$4,800 for the Streaky Bay Rodeo by The Sea and \$5000 for the new Celebration of Seafood at Streaky Bay event. Council resolved to support the Rodeo and will provide \$500 of in-kind support to the Celebration of Seafood at Streaky Bay event.

A Frame Signage

Following recent public enquiries regarding the placement of A Frame signage an audit of the signage was taken across the district. It was identified that there were several non-compliances with the By-Law and further investigation indicated that the By-Law was quite prescriptive and limiting in being able to compliantly place out A Frame signs.

A report was presented to Council for Council to endorse a review of the By-Law with a view to amendment to better accommodate such signage.

INFRASTRUCTURE

CCTV – Moore's Boat Ramp

Cr Gunn and Cr Hackett moved a motion without notice to investigate the cost of purchasing and installing CCTV at the Moore's Boat Ramp and the Streaky Bay Jetty.

Starling Control

Cr Wheaton and Cr Hackett moved a motion that \$4,000 be placed into next financial years budget to investigate options for Starling Control.

Skating and Scooting on Footpaths

Mayor Barber asked if Council staff can investigate solutions to reduce or prohibit the speed of people skating and scooting on footpaths.

The Manager of infrastructure and civil works will investigate options and report back to the March 2021 ordinary meeting of Council.

Construction Grader Replacement

Tenders have been called for the replacement of the John Deere Construction Grader. Vendor Panel members have been notified, as well as all prospective local interests. The Tender closes on the 26th of February, with Delivery required by June 2021.

Streaky Bay Jetty Pool Platform Extension and Shade

Tenders have been called for the above project. As part of the Drought Funding project list, Council agreed to allocate funds for the provision of a shade.

At the same time, the Jetty Pool Committee had been working on a Platform Extension.

Complications arose around the lack of engineering data for the existing platform, and then intern not being able to attach a shade to the existing platform.

Golf Course Update

Appeal Process

Council proceeded and advised its legal team to lodge an appeal to Judge Charlesworth's regarding Native Title over the Streaky Bay Golf Course. This appeal was lodged on January 15, 2021. The appeal can be revoked if required.

Both the State and the Wirangu People have filed a 'Notice of Address for Service' (on 28 and 29 Jan 2021 respectively), which confirms they have been served with the appeal documents. Council is waiting for the Federal Court to set a 'first return date'.

As part of the appeal application Council sought some time to negotiate directly with the Wirangu People. An initial meeting has been held (dealt with later in this update).

The appeal is a two-stage process, with first requiring the Council to obtain the Court's 'leave' (permission) to appeal. Prior to that hearing, several documents, prescribed by Federal Court rules, will be required to be prepared. They include an outline of submissions and list of authorities.

If leave to appeal is granted, the Federal Court will set an appeal hearing date.

Public Meeting

A public meeting was held on 20 January 2021 at the Streaky Bay Golf Club commencing at 7.00pm. The meeting was well attended and all those in attendance were in favour of the lodgement of the appeal.

Can any new evidence be presented as part of the appeal?

No new evidence is allowed. Further evidence supporting Council's claim to the intention to sign and existence of a lease has however come to light to since the hearing before Justice Charlesworth, i.e., after 10 August 2020, and an adjustment to the initial appeal documents is being developed as a result.

What evidence (if any) has the claimant presented that has granted the claimant the previous determination? (this was the most repeated question, including "what is their intention, what is significant here?" which the Mayor advised we did not have those answers).

We do not know what evidence of native title the Wirangu Applicant has presented (which, in this case, means 'shown to the State'). We do not know what the Wirangu People's intention (if any) is in relation to the Golf Course. We do not know if the Golf Course land or any part of it has any significance to the Wirangu People. At the meeting discussed later in this brief, however the Wirangu people did outline their wish to not interfere with the operations of the Golf Club.

The first question above appears to assume that the Wirangu People have a determination of native title in their favour. That has not happened yet, at least in relation to the 'Wirangu No 2 Part A' claim. It is the No 2 Part A claim which covers the Streaky Bay township including the Golf Course. A determination of native title continues to be negotiated between the Wirangu Applicant, the State, and the other respondent parties. However, the only issue now outstanding is whether the physical creation of the Golf Course has extinguished native title over those parcels of land.

The Council has previously instructed that it is not going to dispute that the Wirangu People have native title. The Council has decided to leave it to the State and to the Wirangu People to negotiate and, if possible, agree where (if anywhere) the Wirangu People have native title and what rights are part of that native title (for example, the right to camp or live on land). That was a very proper and very sensible decision, given the enormous cost and effort involved in disputing native title. We are not aware of any South Australian council which has actively contested a native title claim.

The only issue which the Council has decided to contest is whether native title has been *extinguished* in relation to the Golf Course land. This assumes that there was native title in the first place, for it to be later extinguished. Justice Charlesworth proceeded in that way. Her Honour assumed that native title exists in the Golf Course unless extinguished. All the parties (including the Council) agreed this was the correct approach in the circumstances, because the dispute was only about extinguishment. This meant that it was unnecessary for the Wirangu Applicant to adduce any evidence of native title, and the Wirangu Applicant did not adduce any such evidence before Justice Charlesworth.

Further, because the Council has sensibly decided not to contest the Wirangu People's native title, the Council has not been shown any evidence of native title. The Wirangu People have shown this evidence, confidentially, to the State. We expect that this evidence would comprise at least one expert anthropologist's report and possibly several witness statements from Wirangu persons. It might also include extracts from various historic publications.

** NOTE: All responses to questions asked at the public meeting have been answered by Council's solicitors.*

Meeting with Wirangu Committee

Following the communication regarding a request to communicate with the Wirangu Committee, Council then received email communication from the lawyers for the Wirangu People proposing a time to meet with Council representatives on 18 February 2021.

This meeting was undertaken with key personnel and stakeholders and was a very successful first step. Key concerns and information for both parties was discussed and further meetings into the future are being scheduled.

PARKING OPTIONS

Issued raised

- ❖ Caravans and other towing vehicles parking along designated angle parks throughout the township
- ❖ Poor parking conditions in existing carpark areas
- ❖ Lack of disabled access parking near Chemist
- ❖ Congestion at intersection (round-a-bout) Wells Street and Bay Road with ordinary vehicles and towing vehicles parked close to intersections
- ❖ No caravan parking near the Visitor Centre

As measures to mitigate these issues Council is considering the following options;

AREAS FOR CARAVANS TO PARK

Highlighted areas in blue on Map 1 and 3

Area 1 – Carpark adjacent to Killa's Fuel n Tackle (Wells Street)

This area is currently not owned by Council. Council could consider taking on a lease agreement/care and control to seal and line mark the parking area. Designated entry and exit points would be constructed as part of the development.

Area 2 – Council Carpark area (off Wells Street end)

This area is owned by Council and is a sealed park. This park could be line marked and designated entry and exit points would be constructed from the Wells Street end.

Area 3 – Vacant Allotment Adjacent Boat Mechanic (Bay Road)

This area is privately owned and would have to be considered the same as Area 1.

Area 4 – Old Tennis Courts Site

This area is under the Care and Control of Council. This area could act as a service area for those accessing the Visitor Centre.

This site is currently zoned as Parklands and the zoning would need to be investigated to ascertain if parking is an activity permitted. The site is currently unsealed and unformed.

Highlighted area orange on Map 1

This area is privately owned. Council could support parking on the premise through access improvement off Bay Road and potential sealing in conjunction with other sealing programs.

Blue Arrow marked on Map 3

The existing angle parking to be removed and facilitate parallel parking to support Caravans visiting the Visitor Centre and EP Marine.

Or

Put in place 2 more angle parks, noting this mitigation still does not provide for Caravan Parking.

Blue Arrow marked on Map 4

It has been suggested that the angle parking on the Southern side of Alfred Terrace from Philip Street to the old Bank SA building be removed and replaced with parallel parking. This could facilitate towing vehicles to park to access businesses in this area.

PROPOSED NO STOPPING AREAS

Red Arrows Marked on Map 2

No Stopping zone to be in place on the Northern side of Wells Street from Killa's Fuel N Tackle through to the exit point of the carpark behind the Chemist.

No stopping zone to be in place on the Northern side of Wells Street from Bay Road through Alice Haddy Naturopath / Reddings Foodland back entrance driveway. *(Note was suggestion to widen Southern side of this section of road from intersection to Church)*

WHEELCHAIR ACCESSIBLE PARKING

Blue Circle marked on Map 2

It has been suggested this could be a possible location for this type of parking at the southern end of the CBD. It should be considered that 2 existing parks will be required for this to be implemented.

Other Options

Towing Vehicles

In regard to towing (long vehicles) parking in the township they are considered under Rule 200(2) of the Australian Road Rules:

The driver of a heavy vehicle, or long vehicle, must not stop on a length of road in a built-up area for longer than 1 hour, unless the driver is permitted to stop on the length of road for longer than 1 hour by information on or with a traffic control device, or under subrule (2A) or another law of this jurisdiction.

Council has confirmed that a 'long vehicle' is defined in Rule 200(3) of the ARR to mean a *'vehicle that, together with any load or projection, is 7.5 metres long, or longer'* and includes a combination (i.e., a motor vehicle towing a trailer). A 'heavy vehicle' is defined in the dictionary of the ARR to mean *'a vehicle with a [maximum loaded mass] of more than 4.5 tonnes.'*

Council could consider enforcement of vehicles under these road rules. However, this would involve a Council "Authorised Officer" undertaking regular patrols to mark cars and time parking. This could be considered timely and may outweigh the cost of the fines implemented. This may not be a practical approach in these circumstances.

Erect permissive parking control signs

The Council may establish a permissive (timed) parking area to reduce the duration vehicles may lawfully remain parked on Wells Street. This initiative may have the desired result of encouraging long vehicles to park elsewhere where they are likely to frequent Wells Street for longer than say 15 or 30 minutes, or some other time determined by Council and displayed on linear parking control signage. However, long vehicles may lawfully park in these areas where they comply with the relevant permissive parking time.

In the event there were persons (i.e., local residents) who regularly parked in the location who required longer than the (say 15 or 30 minute) limit, the Council could issue exemptions to those persons if it saw fit.

Create a permit zone

The Council may utilise Rule 185 of the ARR to establish permit zones in areas where it seeks to prevent vehicles other than those with the permission of the Council from stopping. This may have the desired effect of preventing long vehicles from stopping on Wells Street. This will require the erection of permit zone signage, which could include time limits, and the issuing of permits on application to the Council.

Modify the street scape to prevent long vehicles from parking at the location

One option available to the Council is to physically prevent long vehicles from parking in the location by erecting some form of barrier, obstruction or break in parking spaces. This may be achieved through the construction of a kerbed area with vegetation and/or bollards, preventing long vehicles from manoeuvring in to, or out of, the relevant parking spaces.

HOLIDAY VISITATION PERIOD OPTIONS

- Camping (dangerous locations, waste, health concerns)
- General Waste and Litter Management
- Beach Etiquette (unsafe driving, unsuitable vehicles)
- Sand Dunes Driving (as above)
- Mobile Phone Connectivity
- Hospitality Industry Opening
- Landscapes SA Office Closure
- Council Principal Office Closure
- Local Businesses – recruitment difficulty
- Caravan/Towing Vehicle
- Compliance (checking of Boat Ramp Permits and Camping Permits)

Not all issues were discussed or under the care and control of Council.

Many of these issues require a cost to implement and Council is now seeking your feedback regarding those costs and the solutions proposed.

It is envisaged that Council would like to receive all feedback by the end of March with a view to a future report to the April 2021 Ordinary meeting of Council to enable implementation as part of future budget considerations.

CAMPING AND CARAVANNING

Not all areas of concern raised by the Community are under the care and control of Council, much of this land is crown land under the responsibility of the Minister for Environment, a full list is available in the full document.

CROWN LAND

Camping is permitted on Crown Land for a period not longer than 21 Days – this applies to Crown Land not under Council Care and Control. Only Department of Environment and Water or SAPOL can enforce legislation applicable to this land.

COUNCIL BY-LAW NO. 4

The By-Law 4 prevents camping along the foreshore and other dedicated Council land.

Perlubie Landing Parking Bay and Rest Area

The Manager of Infrastructure and Civil Works has advised that DIT have provided feedback that this rest area is not defined as a rest area by DIT, and is only considered a Stack Site (storage of rubble, etc) and in considering this are unlikely to keep using it as the preferred site is at the corner of the Poochera-Streaky Bay/Ceduna intersection.

There is damaged infrastructure such as seating at this site, which DIT have advised they will remove but will not replace. They will authorise Council to replace, however Council will be responsible for the ongoing maintenance. This is yet another example of the State Government looking to divest its Assets. The signage at this site was originally funded by Streaky Bay Tourism.

DIT have advised they would consider Council taking on Care and Control of this site; however Council need to consider if the site is appropriate, well utilized, and willing to take on any capital replacement of items, and ongoing maintenance. It is reported that this area serves as a rest stop and information bay for the local community. There are few other areas on Flinders Highway to take a break between Streaky Bay and Ceduna. Often, townships and settlements do not have the infrastructure in place to cater for vehicle/passenger rest stops, particularly heavy vehicles. Perlubie is no exception. This bay is often used by Heavy Vehicles as a rest stop as per Log Book requirements

Signage – Directional and Interpretive

This project is underway and consultation will occur as required.

HEALTH AND OTHER SERVICES

A key stakeholder meeting was held Friday February 5, 2021 with representatives of health services, SAPOL and Council. The meeting discussed a variety of topics surrounding the holiday period and pressure placed on many of the services. The key outcomes of this meeting were;

HEALTH

- Additional presentations of minor injuries to hospital and medical clinic
- It was noted that not as many major incidences this year, lots of minor (surfing, fish hooks, etc)
- Covid testing was significantly high and a major impact on services (in particular staffing)
 - o Reported 40 presentations to clinic for testing in 1 day
 - o Persons requiring swabs need to ring 1300 334 222 to make bookings for Streaky Bay (no walk ins accepted)
- Was extremely busy for both Medical Clinic and Hospital (extra staffing required)
- SA Ambulance noted that work load did not increase dramatically over this period

POLICING

- Additional visitation places more pressure on resourcing, noted it is hard to predict the numbers
- Noted that we were lucky no major incidents
- Attended businesses to assist with Covid Management
- Covid questions and testing requirements were an additional requirement this year

GENERAL

- General consensus was that it was the right decision not to host a major event this year, crowd control will need to be high priority for future events
- Port Kenny private gathering – was a good location from services point of view

Streaky's Flashback News

The Express and Telegraph, Mon 29 Oct 1906
ADVENTURE WITH A SHARK STREAKY BAY. October 21

Mr Fred. and. A. Campbell of this town accompanied. by several acquaintances went for a cruise in their cutter on Sunday last after sailing to Pig face Island for bird nesting the party embarked again and started for home.

After they had proceeded a little distance Mr. F. Campbell caught sight of a shark about 150 yards astern of the cutter. The course of the vessel was altered in order to try to ascertain the size of the shark, and in the mean time Mr. W. Keating junior got aft and with, a small rifle started firing at the monster's fin that was showing a few inches above the water.

The bullets landed close to the fin but the shark appeared to take no notice of them. When Mr. Keating ceased firing Mr. F. Campbell got into the dinghy and rowed in the direction of the shade in order to convince him self of its size.

After the small boat left the cutter the fin disappeared for a second or two and when Mr. Campbell got about 20 yards from the larger vessel the fin reappeared 4 or 5 in above the water. He could then, see that it was a very large shark and at once made a stroke with the left hand oar in order to turn the little craft round to face in towards the shore in the direction of the cutter which was sailing slowly along.

Before he could make the second stroke he saw to his horror that the monster was rushing towards him in an instant it seized the dinghy just under her quarters and partly amidships and tossed the small boat clean out of the water to a height of about 3 ft. Mr. Campbell was tossed about 3 ft. higher.

The dinghy was over turned and Mr. Campbell fell into the water landing on his back he immediately sank but soon reappeared and at once seized the gunwale of the boat. He gave her a turn and then seizing her keel continued turning her over and over for some time at the same time looking about in a terrified manner.

The cutter at this time was about 50 yards distant and soon rescued Mr. Campbell from his perilous position, Messrs. Keating and Lewis hauling him aboard. A great state of excitement prevailed amongst those on the larger vessel when they witnessed the boat tossed into the air.

Mr Campbell was at once divested of his clothes and received a good rubbing down but after a time he fainted and has been confined to his bed for the last two days evidently suffering from shock and the tossing he received.

A strange part of the adventure is that the shark cleared right away directly after it capsized the boat and was not seen again.

- Hot Water Services (250lt)
